## Vatican report on investigation into ex-Cardinal McCarrick released



Two years after Pope Francis called for a full accounting of how Theodore McCarrick was able to rise through church ranks and promised to make the report public, the McCarrick report was issued on Nov. 10, 2020. Archbishop Jose Gomez called the just-released report "another tragic chapter in the church's long struggle to confront the crimes of sexual abuse by clergy."

Before concluding his weekly general audience Nov. 11, the pope made his first public statement on the release of the report regarding the "painful case" of the former cardinal.


