St. Hedwigs Village/VA PSHP Luzerne (Kingston, PA)

- St. Hedwigs provides 12 clustered apartments (10 1-bedroom and 2 2-bedroom) for homeless **male and female disabled veterans**, including those **with families**
- VA PSHP Luzerne provides 11 scattered site furnished apartments (9 1-bedroom and 2 3-bedroom)
 - For 9 homeless **veteran individuals** and 2 homeless **veteran families** with disabilities
- Provides supportive housing and case management for homeless veterans with qualifying disabling conditions.
