



## 2026-27 School Tuition for Epiphany School

Our goal is to keep tuition costs affordable for all families while also being transparent about the true “Cost To Educate” (CTE) at your school. To achieve this goal, the Diocese of Scranton Catholic Schools Office presents the tuition structure model that shares the CTE at your school and offers options to families to reduce this cost to educate to help keep tuition payments at a manageable level.

The Diocese of Scranton is offering a Guaranteed Scholarship to families who participate in one of the following 3 options. The cost to educate a student at Epiphany School is **\$9,564.00**. To reduce the CTE, follow these steps:

### 1. **Apply for Tuition Assistance which can be done during the online enrollment process.**

Applying offers you the Guaranteed Scholarship. The Diocese of Scranton Catholic Schools Office works with a third-party vendor, FACTS Grant and Aid, to evaluate all applications. Using objective criteria, the applications are ranked according to need within each school. If you qualify for Tuition Assistance, the amount awarded will be applied to the discounted rate.

- **Apply for an Epiphany School Scholarship.**

- By completing the Tuition Assistance application as described above, you will automatically be considered for the Epiphany School Scholarship. You may qualify to reduce tuition even further beyond the discounted rate listed in the chart below. Epiphany School Scholarships are discretionary and, when awarded, are applied in addition to the discounted rate.

### 2. **Participate in the State Tuition Tax Credit Program** (also referred to as the EITC Scholarship program as presented by RedefinED in the fall). Apply to direct your PA state tax to **Epiphany School** through an EITC program and receive a tax credit of 90% of the amount you pay in.

### 3. **Out of State Families** - Donate to the Epiphany School Tuition Scholarship Fund. Given the proximity of Epiphany School to NY, we are aware of families who do not live and work in PA. Given this scenario, families may not have PA tax liability and would not be eligible to receive PA EITC scholarships due to the out of state residence. For families in this scenario, donate a minimum of \$1,000.00 to the Epiphany School Scholarship Fund restricted for scholarships for Epiphany School students. \*\*See below how to donate.



## 2026-27 School Tuition for Epiphany School

By choosing to complete one of the three options available to decrease your Cost To Educate, you will automatically receive a Diocese of Scranton Guaranteed Scholarship Award and be charged the amounts listed in the charts below. This guaranteed scholarship will be immediately applied to your tuition before any other discounts or assistance awards. Below will be your tuition amount for 2026-2027 if you apply for one of the three options. If you do not participate in one of the three options, you will be charged the cost to educate: **\$9,564.00**.

### Kindergarten – 6<sup>th</sup> Grade

1 <sup>st</sup> child in the family	\$6,930.00

3 <sup>rd</sup> child in the family	\$5,720.00
4 <sup>th</sup> child in the family	\$3,090.00

<b>Pre-Kindergarten</b>	<b>Annually</b>
2 Half Days	\$3,645.00
3 Half Days	\$4,330.00
5 Half Days	\$4,870.00
2 Full Days	\$4,590.00
3 Full Days	\$4,965.00
5 Full Days	\$6,310.00

NOTE: You have the following opportunities to reduce the tuition as listed above even further. In some cases tuition costs can be lowered by half or more.

- **Participation in the sale of Lotto Tickets**
